Introduction to the 6th ICLARS Conference

The general theme of the 6th ICLARS Conference —*Human dignity, law, and religious diversity: Designing the future of inter-cultural societies*— fully connects with the concern raised by the current increasing trend towards polarization, in almost every area, including the citizens' religious and ethical choices. On the premise that freedom of thought, conscience and religion is one of the human rights that define every person's inherent autonomy, the aim of the conference is to analyze how the notion of human dignity, which constitutes the central axis of the 1948 Universal Declaration of Human Rights, can contribute to create common ground between competing concepts of human rights.

In the realm of freedom of religion or belief, contemporary societies experience numerous challenges if they want to truly qualify as inclusive, for radical positions —religious or antireligious— are on the rise, and those who think differently are regarded as actual or potential enemies. This conference does not aspire to solve those problems, among other reasons because, as all serious social issues, they are not susceptible of easy solutions. However, the conference does want to contribute to generate a culture of respect for diversity, specifically where the citizens' religious and ethical choices are concerned. To this purpose, it is indispensable to understand that religious and ethical choices are not something incidental or inconsequential but part of the very identity of a person.

The contribution of the various branches of government (legislatures, governments and the judiciary), as well as civil society and international institutions, to the promotion of a culture of respect for freedom and pluralism will occupy an important place in the structure of the plenary sessions of the conference. These will be held in the mornings, in the Palacio de Congresos de Córdoba, and will have simultaneous interpretation Spanish-English.

The parallel sessions will be held after lunch, in any of the five working languages of the conference: Spanish, English, Italian, French or Portuguese. Their high number —seventy— and the diversity of their subjects is the result of an extraordinary positive response to the conference call for papers and panels. This is an expression of the great interest that these issues raise in academia and the vitality of this branch of legal studies —law and religion— all over the world. Due to space needs, parallel sessions will be held in various locations, within walking distance, in a maximum radius of approximately 300 meters from the Palacio de Congresos.

The organization of the 6th ICLARS Conference has been carried out by LIRCE (*Instituto para el Análisis de la Libertad y la Identidad Religiosa, Cultural y Ética* – Institute for the Analysis of Religious, Cultural and Ethical Freedom and Identity), which, as indicated in the program, has worked in collaboration with a number of sponsoring public and private institutions; it has also relied on the invaluable help of an Organizing Committee composed of professors of several Spanish universities and a Scientific Committee constituted by the ICLARS Steering Committee; and it has had the unconditional support of an Honorary Committee presided by HM King Felipe VI of Spain and made up of persons of great prominence in Spanish society. To all of them, our sincere gratitude for having made this conference possible.

Presentación del VI Congreso del ICLARS

El tema general del VI Congreso del ICLARS —*Dignidad humana, derecho, y diversidad religiosa: diseñando el futuro de sociedades interculturales*— conecta plenamente con la inquietud que suscita la creciente polarización de las sociedades contemporáneas en casi todos los ámbitos, incluido el de las opciones religiosas y éticas de los ciudadanos. Partiendo de que la libertad de pensamiento, conciencia y religión es uno de los derechos humanos que definen la autonomía esencial de la persona, se trata de analizar cómo la noción de dignidad humana, que constituye el eje central de la Declaración Universal de Derechos Humanos de 1948, puede contribuir a crear un terreno de entendimiento común entre concepciones antagónicas de los derechos humanos.

En el ámbito de la libertad de religión y creencias, son numerosos los desafíos que experimentan las sociedades contemporáneas para poder ser calificadas verdaderamente de inclusivas, pues van en aumento las posiciones radicales de signo religioso o antirreligioso, que miran a quien piensa diferente como un enemigo real o potencial, y al que, por tanto, hay que combatir o excluir. Naturalmente, este congreso no pretende solucionar esos problemas, entre otras razones porque, como todos los grandes desafíos sociales, no admiten solución fácil. Pero sí quiere contribuir a crear una cultura de respeto por la diversidad, concretamente en el ámbito de las opciones religiosas y éticas. Para lo cual es imprescindible comprender que las opciones religiosas y éticas no son algo accesorio o poco relevante, sino parte de la identidad misma de la persona.

La contribución a la creación de una cultura de respeto por la libertad y el pluralismo por parte de las diferentes instancias de gobierno (legisladores, gobiernos, jueces), y también de la sociedad civil y las instituciones internacionales, ocupa un lugar preferente en la estructura de las sesiones plenarias del congreso, que tendrán lugar por las mañanas, en el Palacio de Congresos de Córdoba, y contarán con interpretación simultánea español-inglés.

Las tardes se dedicarán a las sesiones paralelas, que se celebrarán en uno de los cinco idiomas de trabajo del congreso: español, inglés, italiano, francés o portugués. Su elevado número —setenta— y su diversidad temática es resultado de que la respuesta a la convocatoria de paneles y ponencias fue extraordinariamente positiva. Lo cual demuestra el interés que estas cuestiones suscitan en el ámbito académico, y la vitalidad que esta rama de los estudios jurídicos —derecho y religión— tiene en todo el mundo. Por necesidades de espacio, las sesiones paralelas se celebrarán en distintas sedes, todas ellas en un radio máximo de aproximadamente 300 metros desde el Palacio de Congresos, y de fácil acceso a pie.

La organización de este VI Congreso del ICLARS ha sido confiada a LIRCE (Instituto para el Análisis de la Libertad y la Identidad Religiosa, Cultural y Ética), que, tal como recoge el programa, ha actuado en colaboración y con el patrocinio de numerosas instituciones públicas y privadas; ha contado con la inestimable ayuda de un Comité Organizador integrado por profesores de distintas universidades españolas y un Comité Científico compuesto por el Consejo Directivo del ICLARS; y ha tenido el incondicional apoyo de un Comité de Honor presidido por S.M. el Rey Felipe VI de España y compuesto por personas de gran relieve en la sociedad española. A todos ellos nuestro sincero agradecimiento por haber hecho posible este congreso.



